THE SUBJECT OF THE AGREEMENT IS THE INVESTMENT OF THE AMOUNT OF _____ IN THE
MISTER DZIRLO PROMO ELECTRIC CAR PROJECT

ARTICLE 2

THE INVESTMENT FUNDS HAVE THE TREATMENT OF INVESTMENT AND EXCLUDE THE RIGHT TO
PARTICIPATE IN THE OWNERSHIP STRUCTURE OF THE INTERNATIONAL HOLDING COMPANY MISTER DZIRLO.

ARTICLE 3

INVESTED FUNDS HAVE THE TREATMENT OF A LOAN AND SO ARE RECORDED IN THE ACCOUNTING RECORDS
OF THE RECIPIENT OF THE BORROWED AMOUNT.

ARTICLE 4

WITH INVESTED FUNDS, THE INVESTOR ACQUIRES THE RIGHT, AND BASED ON OWNERSHIP OVER THOSE
FUNDS, TO ACHIEVE A MONTHLY PROFIT IN THE AMOUNT OF PROFIT OF THE MISTER DZIRLA INTERNATIONAL
HOLDING COMPANY.

THE MINIMUM GUARANTEED AMOUNT IS 3% OF THE INVESTED AMOUNT.

ARTICLE 5

ARTICLE 9

ARTICLE 10

IN THE CASE OF A NEGATIVE AMOUNT INDICATOR APPEARING, THE RECEIVER INFORMS THE INVESTOR OF THE TERMINATION OF THE BUSINESS RELATIONSHIP AND RETURNS THE ENTIRE INVESTED AMOUNT TO THE INVESTOR WITHIN 7 DAYS.

ARTICLE 11

IF THE INVESTOR IS A BUYER, 3% OF THE VALUE OF THE PURCHASED CAR IS RECOGNIZED TO THE BUYER AS THE AMOUNT INVESTED IN THE MISTER DZIRLO PROMO ELECTRIC CAR PROJECT.
